The Norwegian NCP is established as an impartial, independent public body that gives legally non-binding advice in accordance with the Guidelines. The Secretariat is located in the Ministry of Foreign Affairs' offices, but is independent of the Ministry. The NCP has four members who are appointed on the basis of their professional expertise and experience. Gender balance is to be sought. The members are nominated by the Norwegian Ministry of Foreign Affairs and the Ministry of Trade, Industry and Fisheries, after consultations with the Ministry of Finance and the Ministry Labour and Social Inclusion, on the basis of recommendations from business (Confederation of Norwegian Enterprise, NHO), trade unions (Confederation of Norwegian Trade Unions, LO) and civil society organisations (Forum for Development and Environment). The members are appointed by the MFA. The chair is appointed for four years, and the remaining three members for three years at a time. Members may be re-elected once.

The OECD Guidelines for Multinational Enterprises are central in the Norwegian Transparency Act. The Act was passed in June 2021 and entered into force on 1 July 2022. The Transparency Act § 4 requires enterprises to carry out due diligence in accordance with the OECD Guidelines. The definition of due diligence is closely aligned with the due diligence steps and supporting measures in the OECD Due Diligence Guidance for responsible business conduct (2018).

The purpose of the Transparency Act is to promote enterprises' respect for fundamental human rights and decent working conditions in connection with the production of goods and the provision of services and to ensure the general public access to information regarding how enterprises address adverse impacts on fundamental human rights and decent working conditions. The Act applies to larger enterprises that are resident in Norway and that offer goods and services in or outside Norway. The Act also applies to larger foreign enterprises that offer goods and services in Norway, and that are liable to tax to Norway pursuant to internal Norwegian legislation.

G. Challenges

57. Has the NCP faced any particular challenge(s) it would like to highlight this year?

The NCP is handling several complex specific instances. A recurring challenge is to keep the time schedule for the different phases of the case handling. Furthermore, offering professional mediation involving sufficient subject matter expertise has significant budgetary implications.

The demand for guidance and training on the OECD Guidelines and due diligence guidance has substantially increased after the Transparency Act was passed in 2021 and entered into force in July 2022. The NCP also notes an increased demand for guidance in relation to other regulatory developments. The NCP could have executed more promotional activities, such as specific courses/training, but does not have sufficient resources to meet all requests.

The Norwegian NCP has issued two new tools in 2022:

A digital due diligence tool

The tool is based on the NCP's introduction guidance to the OECD Due Diligence Guidance for Responsible Business Conduct. The target group is enterprises that are not very familiar with due diligence.

The respondent replies to statements about measures based on the six steps in the due diligence guidance, that is whether the statement is correct – partly correct – not correct. The result for each step is illustrated with a speedometer, demonstrating how much is done and how much is left.
